### Declarations of the legal guardian

1. I declare that I am the legal guardian of the minor stated above and I **give my consent** to their participation in shooting or a shooting package at the Operator's Range.
2. I will be personally present throughout the minor's participation in the shooting. I acknowledge that shooting by a minor takes place exclusively under the direct supervision of the Operator's instructor in accordance with Act No. 90/2024 Coll., on Weapons and Ammunition.
3. I have read the Operator's General Terms and Conditions, the Operating Rules of the Range and the safety rules, and I undertake to ensure that the minor complies with them. The language of the safety briefing and instruction is Czech and English.
4. I acknowledge that the scope of the minor's shooting is determined primarily by their physical and mental maturity and that the instructor or the range officer may restrict the selection of weapons, adjust the course of the shooting, or interrupt or terminate the shooting; such a decision is made solely in the interest of safety and is final (Section 18 of the Weapons Act). In such a case, I may consume the unused ammunition on site myself, unless safety or legal reasons prevent this.
5. I declare that the minor is medically fit to shoot, is not under the influence of alcohol or other addictive substances, and that I am not aware of any circumstances that would prevent their safe participation.
6. I acknowledge the obligation of the minor and the accompanying persons to use the prescribed protective equipment (hearing and eye protection) throughout their stay in the range area and to follow the instructions of the instructor and staff.
7. Liability for damage is governed by the Operator's General Terms and Conditions and by law.
8. The personal data provided in this consent form are processed by the Operator for the purpose of performing the contract and complying with legal obligations under the Weapons Act; detailed information is provided in the Privacy Policy available on the Operator's website.
